A wire mesh fence will contain the debris as much as possible. They want to be good neighbors. Ground breaking will be on Tuesday, Aug 16, the fence will go up on Wed or Thurs. Completion date is October 2015. Traffic will move at 10 mph or less, and egress is on 29<sup>th</sup> St and 15<sup>th</sup> Ave So. If there are any complaints, please contact Eric and he will contact Drew or Sean.

Cascade ridge retention pond has been sprayed for mosquitos and the wire fence with rags has been removed. 16 added units are in the planning. Funding is possible from the State.

Weeds and hedgerow are in need of trimming. The neighbors are in favor of this building if there is need of it in the community. Management and care are concerns.
