WHAT IS A "CRISIS NURSERY" A crisis nursery is defined as a licensed facility, which provides short-term, 24 hour nonmedical residential care and supervision for children under six years of age, who are either voluntarily placed for temporary care by a parent or legal guardian due to a family crisis or a stressful situation...

are most vulnerable to child abuse and neglect

The "Crisis Nursery" will Infants and toddlers eliminate the need for parents to leave their children in the care of questionable caregivers

HOW LONG CAN THE CHILD STAY AT THE "CRISIS NURERY"... Children can stay for up to 72 hours. However, a child will not be returned to an unsafe environment. There is no limit on how often a family can utilize the services as long as they are in crisis.



72% increase in new child abuse cases in the last 5 years in Cascade County

WHO USES A "CRISIS NURSERY"..... Parents who care enough about their children ask for help!!! Parents who are facing emergencies as well as the cumulative effect of stress. Parents are so overwhelmed that they may not be able to provide their child with a safe environment. Parents who don't have family or other support structure in place. Parents who are facing a variety of issues. Any one of which can easily lead to a crisis situation and result in abuse or neglect of the child

The "Crisis Nursery" will offer supportive services that link parents and caregivers to community resources to help them cope and problem-solve while keeping their children safe.
