### New Business:

  - o Mr. McCoy has had some concerns about crime in W. Kiwanis park due to the lack of lighting. There were 2 responses in 2013 and 9 in 2014.
  - o For the first quarter:
    - 11 abandoned vehicles, 4 accident/injury, 3 assaults, 4 DUI, 3 Narcotic, 31 suspicious activity, 20 thefts, 17 vandalism, 35 wanted/warrant arrests

#### Other Business:

- Airport Sound Mapping Public Meeting- Mary Willmarth. Wednesday May 27 in the Panorama room from 5:30-7pm. There are preliminary maps at Planning and Development, City offices, Library and on the Airport website.
  - o Comment period is 30 days and will end June 19<sup>th</sup>.
  - o This meeting focuses on the entire study
- We will not be meeting for the summer months, however we are having a special meeting June 24<sup>th</sup> to update on Holman building after the Council of Council meeting. Motioned by Mr. McCoy, 2<sup>nd</sup> by Vice-Chair Patera, unanimous decision.
- Council of Councils: Chair Strickland will speak on Holman update- that we sent our letter out.
  - o Council 7 wants to possibly get ordinances changed so mobile vendors can be down at Gibson once Park & Ponder is torn down.
  - o Council 3 wants to possibly talk about traffic and resolutions after the housing boom up top
