The traffic on 32^{nd} St and 10^{th} Ave So was discussed. The light programming the way it was seems to be better. There is no right turn lane on the south side of 10^{th} . Traffic is cutting through the gas station. 32^{nd} St was supposed to have been straightened out. Parking on 32^{nd} St and on 11^{th} Ave is cause for safety concerns.

Jessica Christ, Bishop of the Montana Synod ELCA, asked us to support a Conditional Use Permit to allow contractors for their new office building at 2415 15th Ave So to park and live their RV's while erecting the building. A motion was made by Mac and seconded by Terry to have Eric write a letter of support for this issue.
