New Business:

Neighborhood Watch: Carol Bronson attended the meeting as the coordinator from the Cascade County Neighborhood and Business Watch. The newly revamped program is being aligned with the nine neighbor councils and the Black Eagle civic club as well the town of Cascade.

George Wheeler introduced himself as an interested citizen in serving on the council.

A motion to appoint George Wheeler to Council #7 was made by Amber Colton – Gardner. Tracy Houck seconded the motion. The motion passed unanimously.

Announcements: City Commissioner Bob Kelly introduced himself. His residency is in Neighborhood Council 7.

Community Policing Report: BRIC Officer Tad Kimmit gave an update on the different activities and projects he has been working on in the last six months. He has been working with both businesses and residents to get the Neighborhood and Business Watch programs running. He is working on compiling comparison stats for us in the future. He commented that there is a downtown safety plan that many groups are involved with as well as the BID.

Community Leadership Institute: Travis Harp and Amber Gardner brought information regarding NeighborWorks Community Leadership Institute and their interest Survey. This project is a follow up from the NeighborWorks Community Leadership Institute summit in Orlando FI this autumn.

Travis shared his experience in attending the workshop and his take-always from the summit. The Great Falls team in attendance is taking on the initiative of distributing an interest survey with a focus on the neighborhood councils. Tis survey will help gauge interest and determine topics for developing a local Great Falls Community Leadership Institute. These training a will be open to the community but there will be a targeted marketing focus to the Neighborhood Councils and Neighborhood Watch.

Calumet Montana Refining Company proposed zone change - Jason Lehmann, member of Neighborhood Council 9 presented and brought council two's concerns from ordinance 3900 at the city Calumet Montanan Refining Company and Genco proposed to have acreage on the West Bank re-zoned from commercial to heavy industrial (I2). I It is currently commercially zoned.

Council member Tracy Houck expressed her concerns to the group that once property is zoned for heavy industrial it is very hard to revert back to light industrial or even commercial zone. While this property has not seen any development interest in many years, it has had recent interest and the south end of the West Bank has recently been developed quite nicely. According to the proposal from Calument – they currently do not have a demand for heavy industrial zoning. Light industrial would work for their current business proposal. Tracy Houck shared here concerns that this zone change was applied for in November of 2012 and in less than 90 days the zoning of this property could be changed with a potential high environmental impact. It appears more evaluation needs to be completed and negotiations with Calument establishing provisions for the aesthetics and recreational use of the river front be considered.

Commission Kelly spoke to encourage the council to come to the Janaury 15th city commission meeting and speak our concerns succinctly. He also gave some clarification on the proposal explaining the zoning needs of Genco which is also involved in the rezoning proposal.

A motion was made by Tracy Houck that **Neighbor Council #7 would like their concerns expressed to the city commissioners that more research and evaluation for the long term stability of our community be done before the l2 rezoning is approved**. The motion was seconded by Amber Colton – Gardner. The motion passed with Jim Super abstaining for the vote.

A motion was made by Tracy Houck that **George Wheeler be appointed as the Neighborhood Council #7 liaison to the Downtown Development Partnership** effective upon his appointment to Neighbor Council #7 at the next City commissioners meeting February 5, 2013. The motion was seconded by Amber Colton – Gardner. The motion was unanimously approved.
