Kristal Kuhn, Emergency Planner from Great Falls Fire Services presented information on the many upgrades that the City of Great Falls and Cascade County is having with emergency response and calls. Ms. Kuhn also presented information on a grant that the City of Great Falls is to receive from the United States Department of Homeland Security. Citizen Joseph Bichley residing at 1413 27<sup>th</sup> Ave S raised a question about the non-emergency number for Great Falls services.

Bob Moretti representing the Great Falls Public Schools mill levy, presented information and took questions about the mill levy that Great Falls Public School District is asking for. Citizens Beau Stingley residing at 221 6<sup>th</sup> Ave N; Nathen Weilborn residing at 3533 8<sup>th</sup> Ave S; Derian Keels residing at 3630 6<sup>th</sup> Ave S; Blake Moczygemva residing at 3805 4<sup>th</sup> Ave S all spoke in favor of passing the Great Falls School District mill levy.

Mary Sheehy Moe, Montana Senate District 12 candidate presented a brief background and spoke on the upcoming election where she is running for the State Senate representing District 12. Citizen Trudi Schmidt residing at 4029 6<sup>th</sup> Ave S emphasized the importance of the homelessness rate in Great Falls and the state of Montana.

Carli Boland, Montana Senate District 13 candidate presented a brief background and spoke on the upcoming election where she is running for the State Senate representing District 13.
