Child is allowed to stay up to 72 hours no questions asked. They have paired up with the Early Childhood Coalition and UGF Marketing students to create a business plan by summer. They are not funded by the government and need volunteers. There was mention of the group Family Promise which is in all cities but Great Falls, keeps families together versus splitting them up like at the Rescue Mission. CCHD plans to teach parenting skills and use home visits for this.
- Neighborhood Watch- would like NH Councils to help recruit. Would try to get a flier in the Wednesday envelope at West Elementary and get a watch formed in NHC#2. Sue offered to spearhead along with Eric Ray and Carol Bronson.
