- **NEW BUSINESS:** Don Sterhan of Mountain Plan\ins Equity Group gave an update on Cascade Ridge II. Low Income Tax Credits for finance have been approved. Forty units were applied for in 90 days. 100 are on the waiting list. Sixteen more units will be built. US Bank is buying the Tax Credits. First Interstate Bank is providing the construction loan. The start date is early June with a one year construction timeline. May 7th is the Bid Opening date. Bidders are: Sletten, Fisher, Talcott, PacWest of Idaho and Dick Anderson Construction. We will have a meeting with the site foreman about concerns. Lowell Springer, architect, said that, "They will watch for it (dust) and we will listen."

The hedgerow needs to be maintained. We have a good relationship and have learned from past mistakes. We want to keep the relationship going.

PETITIONS AND COMMUNICATIONS

Gail Dean talked about the petition for an All Way Stop Sign at the intersection at 11th Ave So and 32nd St. There are about 50-60 signatures currently and more to be collected. She will bring it to the next meeting.

Talus Apartments construction manager apologized for the mess and garbage in the fences around Central Catholic School area. It was cleaned up and will be monitored in the future.

OLD BUSINESS

Approve Minutes: The minutes were read and approved on a motion by Terry and second by Mac. Reports Mac reported on the Police Advisory Board. Work is being done on the Law Enforcement Memorial. The weather is turning nice so be alert to averting crime. Lock your garage doors. The Devonshires had 5 break-ins of garages-all doors were unlocked.

Assaults on Police Officers are up. There were 14 in all of last year and already 11 this year. Two thirds of Child Abuse Cases in all of the state are in Cascade County.
