ROLL CALL: Members present: Terry Albrecht, Eric Ray, Gloria Bedker, and Marcia Anderson. Mac McFadden is not feeling well. There were 20 neighbors present including Dave Snuggs from My Neighbor in Need, Officer Adam Hunt, and Joc Briggs, candidate for County Commissioner.

Officer Adam Hunt gave the quarterly policing report. Since most of the incidents occur on 10th Ave So., our neighborhood is still one of the safest in town. The DDACTS system is working well. If you want to check on sex offenders in the area, go to NeighborhoodWatchDog.com

Dave Snuggs gave a very well received report on My Neighbor in Need and My Student in Need. They have a 24/7 wish list where some asks for something. Someone anywhere in the world can help. The recipients are asked to Pay It Forward. Applicants answer a 21 question application. Dave proves the need to publish in the paper. The number 1 need is beds. They have helped over 8000 needs after 4½ years. Eleven countries have helped. Dave gets paid in joy. He takes no money. Teachers must vet the needs for My Student In Need. Help has been vetted in 156 schools throughout the state. Winter clothes and food for the weekends are a great need.. With an average budget of \$400,000 per year, the office staff and drivers get paid along with \$100 per month rent in Times Square. Donors get to decide where their money gets spent. The average cost for student need is \$40 and neighbor is \$79.

The Cracker Barrel is not coming to the Walmart complex. Heavy equipment will be gone by November. Turn lights will be put in by the DOT. The first lot has been sold to a restaurant. Thirteenth Ave So will be completed by the end of the year.
