

RESOLUTION NO. 9153

A RESOLUTION ASSESSING THE COSTS INCURRED IN THE NUISANCE ABATEMENT OF PROPERTY LOCATED AT LOT 14, BLOCK 487, GREAT FALLS FIRST ADDITION, GREAT FALLS, CASCADE COUNTY, MONTANA, ADDRESSED AS 723 10th STREET SOUTH, AGAINST SAID PROPERTY.

WHEREAS, the property located at Lot 14, Block 487, Great Falls First Addition, Great Falls, Montana, (described as 723 10th Street South) was issued a notice to repair or raze a garage structure, and

WHEREAS, after due notice the property owner had not repaired nor demolished said building within the time allowed; and

WHEREAS, the contractor has completed the demolition and City staff has approved the work;

WHEREAS, the City Commission set May 5, 2001, at 7:00 p.m., to hear the report outlining the costs incurred in the abatement of said building.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, THAT:

The amount of \$2170.00 for the cleanup and removal costs incurred in the removal of garage materials and concrete slab at Lot 14, Block 487, Great Falls First Addition, Great Falls, Montana, described as 723 10th Street South, be assessed against said property, with interest and penalties on the unpaid balance.
