# A RESOLUTION CREATING A TIER 5 SAFETY INSPECTION CERTIFICATE FEE AND AMENDING THE RATES ESTABLISHED FOR SAFETY INSPECTION CERTIFICATE AND HOME OCCUPATION CERTIFICATE RENEWAL FEES

WHEREAS, The Official Code of the City of Great Falls, in OCCGF 5.01.050, provides for various license and certificate fees to be established by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA:

#### Section 1. - Supersedes and Takes Effect

- A. The Tier 5 Certificate Fee addressed in this resolution establishes a new issuance fee and a renewal fee.
- B. The Certificate Renewal Fees addressed in this resolution establish new renewal fees and supersede previous fees.
- C. The fees shall take effect on the "effective dates" shown in Section 3 of this resolution.

### Section 2. - Special Provisions

- A. <u>Safety Inspection Certificates</u>
  - 1. Tier 5 new issuance fees and renewal fees are herein established
  - 2. Each Safety Inspection Certificate existing on the effective date of this resolution shall, upon renewal, be required to pay the renewal fee established herein.
- B. Home Occupation Certificates

Each Home Occupation Certificate existing on the effective date of this resolution shall, upon renewal, be required to pay the renewal fee established herein.

## Section 3. - Certificate Fees

A. Safety Inspection Certificate New Issuance fees (effective August 1, 2001) shall be:

1. Tier 4 - over 25,000 sq ft to less than 50,000 sq ft	\$210.00 (no change)
2. Tier 5 - 50,000 sq ft and over	\$300.00

B. Safety Inspection Certificate Renewal fees (effective August 1, 2001 and July 1, 2002) shall be:
