

RESOLUTION 9272

A RESOLUTION BY THE CITY  
COMMISSION OF THE CITY OF GREAT FALLS,  
MONTANA, TO VACATE A TRIANGULAR SEGMENT  
OF RIGHT-OF-WAY ALONG THE WEST BOUNDARY  
OF 6<sup>TH</sup> STREET NORTHWEST, IN ACCORDANCE  
WITH THE PROVISIONS OF SECTION 7-14-4114,  
MONTANA CODE ANNOTATED

WHEREAS, plans have been prepared to reconstruct 6<sup>th</sup> Street Northwest between Central Avenue West and the Northwest Bypass; and

WHEREAS, public officials involved in the preparation, review and approval of the construction plans for 6<sup>th</sup> Street Northwest have determined there no longer is a necessity to retain the following described segment of right-of-way:

A tract of land being a portion of 6<sup>th</sup> Street Northwest right-of-way, located in the SW1/4 of Section 2, Township 20 North, Range 3 East, P.M.M., Cascade County, Great Falls, Montana, and being more particularly described as follows;

Beginning at a point on the west right-of-way of 6<sup>th</sup> Street Northwest being the Northeast corner of Lot 8, Block 1, of Amended Plat of a Portion of Fair Acreage Tracts; thence South 15°24' 15" East, a distance of 204.34 feet to a point on the east boundary of said Lot 8; thence North 32°12' 52" West, along said east boundary, a distance of 138.18 feet, thence North 13°36' 25" East, along said east boundary, a distance of 82.40 feet, to the true point of beginning and containing 4082.87sq. ft. or 0.0937 acres.

WHEREAS, the City Commission of the City of Great Falls, Montana, duly and regularly passed and adopted on the 6<sup>th</sup> day of November, 2002, Resolution No. 9270 entitled:

WHEREAS, the City Clerk of said City, forthwith caused notice of said Resolution No. 9270 to be:

- 1) published in the Great Falls Tribune, the newspaper published nearest the right-of-way proposed for vacation; and
- 2) posted in three public places, stating therein the time and place the City Commission shall hear all persons relative to said proposed vacation.

WHEREAS, a hearing was held by the City Commission of the City of Great Falls on the 19<sup>th</sup> day of November, 2002, at 7:00 P.M. in the Commission Chambers of the Great Falls Civic Center, where said Commission heard all persons relative to the proposed vacation of a triangular segment of right-of-way along the west boundary of 6<sup>th</sup> Street Northwest.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF GREAT FALLS, MONTANA;

The triangular segment of right-of-way along the west boundary of 6<sup>th</sup> Street Northwest as described hereinabove is hereby vacated.

BE IT FURTHER RESOLVED BY SAID CITY COMMISSION that this Resolution shall become effective thirty (30) days after its passage and approval.
