A RESOLUTION BY THE CITY
COMMISSION OF THE CITY OF GREAT FALLS,
MONTANA, TO VACATE A PARTIAL CUL-DE-SAC
RIGHT-OF-WAY ALONG THE SOUTH BOUNDARY
OF BLOCK 8, NORTH RIVERVIEW TERRACE ADDITION,
SECTION FIVE, PART ONE, IN ACCORDANCE
WITH THE PROVISIONS OF SECTION 7-14-4114,
MONTANA CODE ANNOTATED

WHEREAS, the subdivision plat of North Riverview Terrace Addition, Section Five, Part One, dedicated a partial cul-de-sac as a part of the right-of-way for Sacajawea Drive along the south boundary of Block 8 of said Addition; and

WHEREAS, the dedicated right-of-way for the partial cul-de-sac or bulb out is a semi-circle with a 50-ft radius located along the north side of Sacajawea Drive between 8th and 9th Streets Northeast; and

WHEREAS, subject partial cul-de-sac was not recognized when the paving, curb and gutter improvements were installed in the involved portion of Sacajawea Drive; and

WHEREAS, the two lot owners abutting subject unimproved partial cul-de-sac have petitioned to have it vacated; and

WHEREAS, an Amended Plat of Lots 13 & 14, Block 8, North Riverview Terrace Addition, Section Five, Part One, has been prepared which shows the distribution of the right-of-way requested to be vacated and reconfiguration of abutting lots; and

WHEREAS, the City Commission of the City of Great Falls, Montana, duly and regularly passed and adopted on the 6th day of April, 2004, Resolution No. 9375 entitled:

WHEREAS, the City Clerk of said City, forthwith caused notice of said Resolution No. 9375 to be:

- 1) published in the Great Falls Tribune, the newspaper published nearest the right-of-way proposed for vacation; and
- 2) posted in three public places, stating therein the time and place the City Commission shall hear all persons relative to said proposed vacation.

WHEREAS, a hearing was held by the City Commission of the City of Great Falls on the 20th day of April, 2004, at 7:00 P.M. in the Commission Chambers of the Great Falls Civic Center, where said Commission heard all persons relative to the proposed vacation of a partial cul-de-sac along the south boundary of Block 8, North Riverview Terrace Addition, Section Five, Part One.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF GREAT FALLS, MONTANA;

The partial cul-de-sac along the south boundary of Block 8, North Riverview Terrace Addition, Section Five, Part One, as described hereinabove is hereby vacated.

BE IT FURTHER RESOLVED BY SAID CITY COMMISSION that this Resolution shall become effective thirty (30) days after its passage and approval.
