The amount of \$5,9577.00 for razing and cleanup costs incurred in the abatement of a nuisance at Lot 9, Block 460, Great Falls Original Addition, Great Falls, Montana, described as 823 6 Avenue South, be assessed against the property itself, with interest and penalties on the unpaid balance.
