The amount of \$2,392.00 for razing and cleanup costs incurred in the abatement of a nuisance at Lot 9, Block 84, Great Falls First Addition, Great Falls, Montana, described as 1123 ½ 8 Avenue North, be assessed against the property itself, with interest and penalties on the unpaid balance.
