

RESOLUTION NO. 9406

A RESOLUTION TO MODIFY THE BOUNDARIES OF SPECIAL LIGHTING DISTRICT – COMMERCIAL LIGHTING “SLD-C” NO. 1295.

WHEREAS, the City Commission of the City of Great Falls, duly and regularly passed and adopted Resolution No. 9406 on the 6th day of July, 2004, which Resolution of Intention to Modify Consolidated Special Lighting District – Commercial Lighting “SLD-C” No. 1295 is now on file in the office of the City Clerk and to which reference is hereby made; and

WHEREAS, the City Commission caused notice of the passage of the Resolution of Intention to be published in the *Great Falls Tribune*, a daily newspaper published in the City of Great Falls, Montana, in the manner and form and during the period as required by law and also caused the City Clerk on the 16th day of July, 2004, that being the day of the first publication of the notice, to mail to each person, firm or corporation, or a known agent thereof, having property within the modification area of the District, to the last known address of such person, firm or corporation or agent, a notice of the passage of the Resolution of Intention; and

WHEREAS, the City Commission having this day met in regular session, at the time and place fixed and mentioned in the Resolution of Intention and in said notices for a public hearing, and the passing upon protests, against the modification of the District, and against the making of the improvements proposed therein; and the Commission having fully heard and considered all of such protests and other testimony.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF GREAT FALLS, MONTANA:

Section 1 The City Commission does hereby find and determine that the protests and each of them made against the modification of the District and against the making of the proposed improvements be and the same are hereby declared insufficient.

Section 2 There is hereby modified a Special Lighting District known as Special Lighting District – Commercial Lighting “SLD-C” No. 1295 of the City of Great Falls, Montana, and the improvements described in the Resolution of Intention are hereby ordered to be made.

Section 3 The boundary modifications of the District shall be the same as described in the Resolution of Intention to which reference is hereby made for a particular description thereof.

Section 4 The City Commission hereby makes reference to the Resolution of Intention for further particulars, including the method of assessing the costs of the improvements against benefited properties.

Section 5 That the modification of this District will supercede and take precedence over any existing, overlapping residential street lighting district boundaries.
