

**RESOLUTION 9411**

**A RESOLUTION FOR THE VACATION OF A PORTION OF HENDERSON PARK IN HENDERSON HEIGHTS ADDITION, NE ¼ OF SECTION 35, TOWNSHIP 20N, R3E**

**WHEREAS**, the City received dedicated parkland known as Henderson Park with the annexation of Henderson Heights Addition in 1987; and

**WHEREAS**, it is desirable for the City to vacate a segment of this parkland located at the southwest corner of the intersection of 30<sup>th</sup> Avenue NE and 5<sup>th</sup> Street NE; and

**WHEREAS**, it is the intent to trade this portion of parkland for street right-of-way on 5<sup>th</sup> Street NE, 29<sup>th</sup> Avenue NE, 30<sup>th</sup> Avenue NE and Skyline Drive; and

**WHEREAS**, the City Commission is empowered pursuant to 7-16-4101 MCA to vacate public park dedication to enable the trade for street right-of-way;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, AS FOLLOWS:**

That the dedication for public park is hereby vacated for 1825 square feet of a portion of parkland known as Henderson Park in Henderson Heights Addition, NE ¼ of section 35 Township 20N, Range 3E at the southwest corner of the intersection of 30<sup>th</sup> Avenue NE and 5<sup>th</sup> Street NE.
