A RESOLUTION OF INTENTION BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, TO EXTEND THE BOUNDARIES OF SAID CITY TO INCLUDE THE AMENDED PLAT OF LOT 4. BLOCK 1, BENEFIS WEST MINOR SUBDIVISION AND AMENDED PLAT OF ST. PEREGRINE ADDITION, LOCATED IN THE SW1/4 OF SECTION 13, TOWNSHIP 20 NORTH, RANGE 3 EAST, CASCADE COUNTY. MONTANA. DIRECTING NOTICE TO BE GIVEN BY THE CITY CLERK AS PROVIDED BY LAW.

WHEREAS, the City of Great Falls is a city incorporated under the laws of the State of Montana, and having a population of more than ten thousand (10,000) is a city of the first class; and,

WHEREAS, there is contiguous to said City, but without the boundaries thereof, certain tracts or parcels of land situated in the County of Cascade, State of Montana, and described as follows:

Amended Plat of Lot 4 Block 1, Benefis West Minor Subdivision and Amended Plat of St. Peregrine Addition, located in the SW1/4 of Section 13, Township 20 North, Range 3 East, P.M.M., Cascade County, Montana, and containing 8.232 acres,

all as shown on the map attached hereto marked Exhibit "A" and by this reference made a part hereof, and according to the Amended Plat of Lot 4, Block 1, Benefis West Minor Subdivision and Amended Plat of St. Peregrine Addition; and,

WHEREAS, Section 7-2-4601, Montana Code Annotated, provides that whenever the owners of real property contiguous to any incorporated city of the first class petition to have said property made a part of the municipal corporation, such lands may be embraced within the corporate limits thereof and the boundaries of such city of the first class extended so as to include the same.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF GREAT FALLS, MONTANA;

That in its judgment it will be to the best interest of said City of Great Falls and the inhabitants thereof that the boundaries of said City of Great Falls shall be extended so as to include: "AMENDED PLAT OF LOT 4 BLOCK 1, BENEFIS WEST MINOR SUBDIVISION AND AMENDED PLAT OF ST. PEREGRINE ADDITION, LOCATED IN THE SW1/4 OF SECTION 13, TOWNSHIP 20 NORTH, RANGE 3 EAST, P.M.M., CASCADE COUNTY, MONTANA."

BE IT FURTHER RESOLVED BY SAID CITY COMMISSION: That Wednesday, the 3rd day of November, 2004, at 7:00 P.M., in the Commission Chambers at the Great Falls Civic Center, Great Falls, Montana, be and the same is hereby set as the time and place for a public hearing at which time the Great Falls City Commission shall hear all persons and all things relative to the proposed annexation of "AMENDED PLAT OF LOT 4, BLOCK 1, BENEFIS WEST SUBDIVISION AND AMENDED PLAT OF ST. PEREGRINE ADDITION, LOCATED IN THE SW1/4 OF SECTION 13, TOWNSHIP 20 NORTH, RANGE 3 EAST, P.M.M., CASCADE COUNTY, MONTANA."

BE IT FURTHER RESOLVED BY SAID CITY COMMISSION that the City Clerk of said City shall, at the aforesaid public hearing before the said City Commission and after expiration of a twenty (20) day period following the first publication of notice of passage of this Resolution, lay before the City Commission all communications in writing by her so received pertaining to said annexation.
