The amount of \$6,302.00 for razing and cleanup costs incurred in the abatement of a nuisance at Lot 1, Block 15, Boston and Great Falls Addition, Great Falls, Montana, described as 3500 5th Avenue North, be assessed against the property itself, with interest and penalties on the unpaid balance.
