

RESOLUTION NO. 9475

A RESOLUTION ADOPTING AN INCREASE IN
SIGN PERMIT FEES

* * * * *

WHEREAS, the City Commission requested that all fees be set by resolution; and

WHEREAS, Ordinance 2786, Amending Title 15, Chapter 15.11 (Sign Code) has been adopted by City Commission, and

WHEREAS, the staff has recommended that the City Commission approve the annual sign permit fee increase:

- 1) Sign Electrician/Journeyman Certificate, an annual fee of \$15.00 (remains the same)
- 2) Sign Erector Certificate, an annual fee of \$15.00 (remains the same)
- 3) Class A License, \$100.00, (remains the same fee)
- 4) Class B License, \$50.00, (remains the same fee)
- 5) Sign Examination Application Fee, \$50.00, (new fee)
- 6) Sign Permit Fees – 25 sq. ft. or more., \$1.25/sq. ft. (new fee)
– 0 to 24 sq. ft., \$30.00 (new fee)
- 7) Neon Lighting – First 100 ft., \$50.00, (new fee)
– 100 ft. or more is \$50 plus \$0.25/ft. (new fee)
- 8) Bench Signs Per Year, \$60.00, (remains the same fee)
- 9) Bench Signs – One Time Design Review Fee, \$25.00 (new fee)
- 10) A-Type Sandwich Board Signs Per Year, \$50.00, (remains the same fee)
- 11) On-Premise Temporary Sign – 60 day permit, \$25.00, (new fee)
– annual permit, \$100.00, (new fee)
- 12) Montana Expo Park – Annual fee for temporary banners, \$500.00 (new fee)
- 13) Central Avenue Banner – 30 Day Maximum, \$50.00 (new fee)
- 14) Pick up fee for Confiscated Signs, \$50.00, (new fee)
- 15) Grandfather Exemptions, Premise \$50.00 plus Sign \$10.00 (new fee)

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, AS FOLLOWS:

That the City Commission of the City of Great Falls does hereby set the permit fee for signs. This fee resolution supercedes all other sign code fee resolutions.
