

RESOLUTION NO. 9493

A RESOLUTION OF INTENTION BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA, TO ADOPT THE GREAT FALLS GROWTH POLICY.

WHEREAS, on April 26, 2005, the Cascade County Board of Commissioners passed a resolution to dissolve the Great Falls City-County Planning Board and associated jurisdictional area, effective July 1, 2005; and,

WHEREAS, with the dissolution of the City-County Planning Board, the Great Falls City-County Growth Policy will no longer be in effect; and,

WHEREAS, without a current adopted growth policy, the City would not be able to perform certain zoning and annexation functions; and,

WHEREAS, in accordance with 76-1-106 MCA, the City of Great Falls has requested the City-County Planning Board prepare amendments to the Great Falls City-County Growth Policy before the effective date of dissolution of the City-County Planning Board; and,

WHEREAS, under the provisions of 76-1-604, MCA, the City Commission is authorized to adopt, revise or reject a proposed growth policy, upon recommendation by the City's planning board; and,

WHEREAS, the City-County Planning Board published in the Great Falls Tribune on May 8, 2005, notice of a Public Hearing on proposed amendments to the Great Falls City-County Growth Policy, in accordance with Section 76-1-602, Montana Code Annotated; and,

WHEREAS, the City-County Planning Board held a public hearing on May 24, 2005 and passed a resolution recommending the City Commission adopt the "Great Falls Growth Policy" as the official growth policy of the City of Great Falls; and,

WHEREAS, the proposed Great Falls Growth Policy is available for inspection at the Office of the Great Falls City-County Planning Board, Civic Center, #2 Park Drive South, Great Falls, Montana.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA:

That Tuesday, the 21<sup>st</sup> day of June, 2005, at 7:00 P. M., in the Commission Chambers of the City Commission, Great Falls, Montana, be, and the same is hereby set as, the time and place wherein said City Commission shall consider adoption of the Great Falls Growth Policy.
