WHEREAS, Apollo Enterprises has petitioned the City of Great Falls to annex Lot 2 of the Amended Plat of Lot 2, Division Addition, in the NE3 of Section 2, Township 20 North, Range 3 East, P.M.M., Cascade County, Montana; and,

Section 2. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
