ORDINANCE NO. 2836--DENIED

AN ORDINANCE CHANGING THE USE CLASSIFICATION ON LOT 2A, BLOCK 1, MONTANA ADDITION TO GREAT FALLS, CASCADE COUNTY, MONTANA, ADDRESSED AS 1608 FOX FARM ROAD FROM ITS "LB" LOCAL BUSINESS DISTRICT CLASSIFICATION TO "GC" GENERAL COMMERCIAL DISTRICT CLASSIFICATION

WHEREAS, on the 24th day of March, 1930, the Council of the City of Great Falls, Montana, passed, and its Mayor, on said last mentioned day, approved a certain Ordinance designated as Ordinance No. 634 entitled: "AN ORDINANCE CLASSIFYING, REGULATING AND RESTRICTING THE LOCATIONS OF TRADES AND INDUSTRIES AND THE LOCATION OF BUILDINGS DESIGNED FOR SPECIFIED USES; REGULATING AND LIMITING THE INTENSITY OF THE USE OF LOT AREAS, AND REGULATING AND DETERMINING THE AREA OF YARDS, COURTS AND OTHER OPEN SPACES WITHIN AND SURROUNDING SUCH BUILDINGS; ESTABLISHING THE BOUNDARIES OF DISTRICTS FOR THE SAID PURPOSES; AND PRESCRIBING PENALTIES FOR THE VIOLATION OF ITS PROVISIONS," and

WHEREAS, said Ordinance No. 634 was recodified and is now contained in Title 17 of the Official Code of the City of Great Falls, adopted upon passage of Ordinance No. 1994 by the Mayor and City Commission on the 6th day of April, 1977, to which said Ordinance and any and all ordinances amendatory thereto or supplementary thereto, reference is hereby made; and,

WHEREAS, said Ordinances have placed the following described property situated in the City of Great Falls, Cascade County, Montana, in a "LB" LOCAL BUSINESS District Classification, as defined therein:

Lot 2A, Block 1, Montana Addition to Great Falls, Cascade County, Montana, addressed as 1608 Fox Farm Road.

WHEREAS, notice of rezoning and changing said use designation on the above-mentioned property from the existing "LB" LOCAL BUSINESS District Classification to a "GC" GENERAL COMMERCIAL District Classification was published in the Great Falls <u>Tribune</u>, advising that a public hearing on this proposed change in zoning would be held on the 4th day of February, 2003, before final passage of said Ordinance herein; and,

WHEREAS, pursuant to said Ordinances, a hearing was duly held after notice thereof was first duly given according to said Ordinances, for the purpose of considering changing said zoning use designation on said property to a "GC" GENERAL COMMERCIAL District Classification; and,

WHEREAS, following said public hearing, it was found and recommended that the said change be made. NOW THEREFORE.

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning use designation on the property hereinabove described be changed from a "LB" LOCAL BUSINESS District Classification to a "GC" GENERAL COMMERCIAL District Classification.

Section 2. All Ordinances and parts of Ordinances in conflict herewith, are hereby repealed.

Section 3. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
