

ORDINANCE NO. 2852

AN ORDINANCE TO AMEND THE LAND USE MAP OF THE GREAT FALLS CENTRAL PLACE REVITALIZATION PROGRAM TO REZONE LOTS 10 & 11, BLOCK 79, ORIGINAL TOWNSITE, FROM COMMERCIAL LIGHT MANUFACTURING (CLM) TO MEDIUM DENSITY RESIDENTIAL DISTRICT (R-3) AND REZONE A VACATED SEGMENT OF 6<sup>TH</sup> STREET NORTH AND AN ABUTTING UNPLATTED SEGMENT OF FORMER PARK PROPERTY FROM PUBLIC LANDS AND INSTITUTIONAL (PLI) TO MEDIUM DENSITY RESIDENTIAL DISTRICT (R-3)

WHEREAS, on December 22, 1977, the Great Falls City Commission adopted Resolution No. 7860 to approve the Great Falls Central Place Revitalization Program and thereby adopted regulations and a Land Use Map for the Revitalization Program area; and

WHEREAS, Title 7, Chapter 15, Part 42 (Section 7-15-4221) of the Montana Code Annotated authorizes the City Commission to modify the Great Falls Central Place Revitalization Program at any time; and

WHEREAS, on April 1, 2003, a petition was received from WRS Architecture & Design, P.C. to amend the land use map of the Great Falls Central Place Revitalization Program to rezone Lots 10 & 11, Block 79, Original Townsite, from Commercial Light Manufacturing (CLM) to Medium Density Residential District (R-3) and rezone a vacated segment of 6<sup>th</sup> Street North and an abutting unplatted segment of former Park property from Public Lands and Institutional (PLI) to Medium Density Residential District (R-3); and

WHEREAS, public notice of the petitioned change has been given by publication of legal notice in the Great Falls Tribune on April 27, May 3, and June 1 and 7, 2003, and by mailing notice in the area covered by the Great Falls Central Place Revitalization Program to the persons whose names appear on the County Treasurer's tax roll as the owners or reputed owners of the property at the address shown on the tax roll; and

WHEREAS, a public hearing on the petitioned amendment to the Great Falls Central Place Revitalization Program was held before the Great Falls City-County Planning Board on May 13, 2003, to assist the Planning Board in making a recommendation to the City Commission on the possible change; and

WHEREAS, the Montana Statutes in effect on December 22, 1977, required adoption of the Great Falls Central Place Revitalization Program by resolution, although House Bill 669 as passed by the 1979 Legislature amended Title 7, Chapter 15, Part 42 (Section 7-15-4221) of the Montana Code Annotated, to require subsequent amendment of such an Urban Renewal Plan by Ordinance; and

WHEREAS, a public hearing was duly held by the City Commission on June 24, 2003, after public notice was first duly given; and

WHEREAS, following said City Commission public hearing, it was found appropriate that an amendment to the Great Falls Central Place Revitalization Program be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the Great Falls Central Place Revitalization Program Land Use Map be amended to rezone Lots 10 & 11, Block 79, Original Townsite, from Commercial Light Manufacturing (CLM) to Medium Density Residential District (R-3) and rezone a vacated segment of 6<sup>th</sup> Street North and an abutting unplatted segment of former Park property from Public Lands and Institutional (PLI) to Medium Density Residential District (R-3).

Section 2. All ordinances, resolutions or maps and parts of same in conflict herewith are hereby repealed.

Section 3. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
