

ORDINANCE NO. 2871

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "A" RESIDENCE USE, "A" AREA DISTRICT, TO LOY SCHOOL AND A SEGMENT OF 57<sup>TH</sup> STREET NORTH IN SECTION 3, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, Great Falls Public Schools, has petitioned the City of Great Falls to annex a 20 acre tract of land occupied by Loy Elementary School in Section 3, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, Great Falls Public Schools has petitioned said 20 acre tract of land be assigned a City zoning classification of "A" Residence Use, "A" Area District, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "A" Residence Use, "A" Area District, to said 20 acre tract of land together with a 2700 foot segment of 57<sup>th</sup> Street North was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 16th day of March, 2004, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of the 20 acre tract of land occupied by Loy Elementary School and a 2700 foot segment of 57<sup>th</sup> Street North in Section 3, Township 20 North, Range 4 East, Cascade County, Montana, be designated as "A" Residence Use, "A" Area District.

Section 2. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
