AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "C" RESIDENCE USE, "C" AREA DISTRICT TO LOT 3, BLOCK 1, OF THE AMENDED PLAT OF LOT 3, BLOCK 1, DIVISION ADDITION, IN SECTION 2, TOWNSHIP 20 NORTH, RANGE 3 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, Apollo Enterprises has petitioned the City of Great Falls to annex Lot 3, Block 1, of the Amended Plat of Lot 3, Block 1, Division Addition, located in the NE1/4 of Section 2, Township 20 North, Range 3 East, P.M.M., Cascade County, Montana; and,

Section 1. That the zoning of Lot 3, Block 1, of the Amended Plat of Lot 3, Block 1, Division Addition, be designated as "C" Residence Use, "C" Area District classification.

Section 2. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
