WHEREAS, C & W Development, Inc., has petitioned the City of Great Falls to annex Berkner Heights Addition, Phase 10, located in the NW1/4 of Section 16, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

Section 2. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
