AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "C" RESIDENTIAL, "C" AREA DISTRICT TO THE UNINCORPORATED PORTION OF THE AMENDED PLAT OF BLOCKS 28 AND 29, LINCOLN HEIGHTS ADDITION AND BLOCKS 1 AND 2 OF THE SOUTH 26TH STREET ADDITION AND INCLUDING PARCEL MARK NO. 18A AND VACATED PORTIONS OF 14TH AVENUE SOUTH AND 14TH AND 15TH ALLEYS SOUTH, ALL LOCATED IN THE NW1/4 OF SECTION 17 AND THE NE1/4 OF SECTION 18, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA, WITH A CONDITIONAL USE TO ALLOW A PARKING LOT UPON SUBJECT PROPERTY

WHEREAS, Benefis Healthcare owns Blocks 28 and 29, Lincoln Heights; Blocks 1 and 2 of the South 26th Street Addition; and Parcel Mark No. 18A in the NE1/4 of Section 18, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, Benefis Healthcare has petitioned the City of Great Falls to annex all of the above described area with the exception of the north half of said Block 28 which is already incorporated into the City; and,

WHEREAS, Benefis Healthcare has petitioned the hereinabove described property be assigned a City zoning classification of "C" Residential, "C" Area District, with a conditional use allowing a parking lot, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "C" Residential, "C" Area District, to the south half of Block 28 and Block 29, Lincoln Heights; Blocks 1 and 2 of the South 26th Street Addition; and Parcel Mark No. 18A in the NE1/4 of Section 18, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana, with a conditional use allowing a parking lot on subject property, was published in the Great Falls <u>Tribune</u> advising that a public hearing on this zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of the south half of Block 28 and Block 29, Lincoln Heights; Blocks 1 and 2 of the South 26th Street Addition; and Parcel Mark No. 18A in the NE1/4 of Section 18, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana, be designated as "C" Residential, "C" Area District, with a conditional use allowing a parking lot on subject property.

Section 2. This ordinance shall be in full force and effect thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor.
