## **ORDINANCE 2893**

## AN ORDINANCE AMENDING OCCGF 3.08.050 PERTAINING TO SMALL PURCHASE PROCUREMENT.

**NOW THEREFORE,** BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GREAT FALLS, MONTANA:

Section 1. That OCCGF Title 3.08.050 be amended as follows:

<u>3.08.050</u> Small purchases. A. Any procurement not exceeding the amount established by 7-5-4302 MCA may be made in accordance with the following small purchase procedures: procedures developed by the City Manager or his/her designee.

A. Purchases between \$ 0 and \$999 the quotation rules shall be set by the department.

B. Purchases between \$1,000 and \$4,999 require three verbal quotes whenever possible to ensure responsible use of City funds.

C. Purchases between \$5,000 and the bid limit specified in the State Statutes require three written quotes attached to the requisition form.

**B.** Procurement requirements may not be artificially divided so as to **avoid** compliance with the prescribe procedures developed in compliance with constitute a small purchase under this section. Supporting quotation documentation related to Items B & C must accompany all claims and purchase requisitions submitted to the Fiscal Control Services Department. (Ord. 2655, 1993)

Section 2. This ordinance supersedes and therefore repeals Resolution 8678.
