

ORDINANCE NO. 2899

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "A" RESIDENCE USE, "A" AREA DISTRICT FOR EAST RIDGE PHASE 2, IN SECTION 16, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, C & W Development, Inc., has petitioned the City of Great Falls to annex East Ridge Phase 2, located in the N1/2 of Section 16, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, C & W Development, Inc., has petitioned said East Ridge Phase 2, be assigned a City zoning classification of "A" Residence District, "A" Area District, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "A" Residence Use, "A" Area District, to said East Ridge Phase 2, was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 1st day of March, 2005, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of East Ridge Phase 2 be designated as "A" Residence Use, "A" Area District classification.

Section 2. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the office of the Cascade County Clerk and Recorder the resolution annexing East Ridge Phase 2 into the corporate limits of the City of Great Falls, Montana, whichever event shall occur later.
