

ORDINANCE NO. 2901

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "C" RESICENCE USE, "B" AREA DISTRICT FOR LOT 1, BLOCK 2, FIRST ADDITION TO GREAT FALLS CLINIC ADDITION, IN SECTION 17, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, Benefis Healthcare, has petitioned the City of Great Falls to annex Lot 1, Block 2, First Addition to Great Falls Clinic Addition, located in the NW1/4 of Section 17, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, Benefis Healthcare, has petitioned said Lot 1, Block 2, First Addition to Great Falls Clinic Addition, be assigned a City zoning classification of "C" Residence District, "B" Area District, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "C" Residence Use, "B" Area District, to said Lot 1, Block 2, First Addition to Great Falls Clinic Addition, was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 15th day of March, 2005, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of Lot 1, Block 2, First Addition to Great Falls Clinic Addition, be designated as "C" Residence Use, "B" Area District classification.

Section 2. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the office of the Cascade County Clerk and Recorder the resolution annexing Lot 1, Block 2, First Addition to Great Falls Clinic Addition, into the corporate limits of the City of Great Falls, Montana, whichever event shall occur later.
