

ORDINANCE NO. 2902

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "C" RESICENCE USE, "B" AREA DISTRICT FOR LOTS 1 & 5, BLOCK 1, MEDICAL TECH PARK MINOR SUBDIVISION, IN SECTION 18, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, Centene Management Company, LLC, has petitioned the City of Great Falls to annex Lots 1 & 5, Block 1, medical Tech Park Minor Subdivision, located in the SE1/4 of Section 18, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, Centene Management Company, LLC, has petitioned said Lots 1 & 5, Block 1, Medical Tech Park Minor Subdivision, be assigned a City zoning classification of "C" Residence District, "B" Area District, upon annexation to City with a conditional use allowing a complex for office buildings; and,

WHEREAS, notice of assigning a zoning classification of "C" Residence Use, "B" Area District, to said Lots 1 & 5, Block 1, Medical Tech Park Minor Subdivision, was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 15th day of March, 2005, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of Lots 1 & 5, Block 1, Medical Tech Park Minor Subdivision, be designated as "C" Residence Use, "B" Area District classification with a conditional use allowing a complex for office buildings.

Section 2. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the office of the Cascade County Clerk and Recorder the resolution annexing Lots 1 & 5, Block 1, Medical Tech Park Minor Subdivision, into the corporate limits of the City of Great Falls, Montana, whichever event shall occur later.
