## ORDINANCE NO. 2903

AN ORDINANCE CHANGING THE ZONING CLASSIFICATION ON LOT 1, BLOCK 1, JEWEL ADDITION TO GREAT FALLS, CASCADE COUNTY, MONTANA, FROM "FIRST INDUSTRIAL", "D" **DISTRICT** AREA TO "PUD" CLASSIFICATION PLANNED UNIT DEVELOPMENT DISTRICT CLASSIFICATION

WHEREAS, on the 24<sup>th</sup> day of March, 1930, the Council of the City of Great Falls, Montana, passed, and its Mayor, on said last mentioned day, approved a certain Ordinance designated as Ordinance No. 634 entitled: "AN ORDINANCE CLASSIFYING, REGULATING AND RESTRICTING THE LOCATIONS OF TRADES AND INDUSTRIES AND THE LOCATION OF BUILDINGS DESIGNED FOR SPECIFIED USES; REGULATING AND LIMITING THE INTENSITY OF THE USE OF LOT AREAS, AND REGULATING AND DETERMINING THE AREA OF YARDS, COURTS AND OTHER OPEN SPACES WITHIN AND SURROUNDING SUCH BUILDINGS; ESTABLISHING THE BOUNDARIES OF DISTRICTS FOR THE SAID PURPOSES; AND PRESCRIBING PENALTIES FOR THE VIOLATION OF ITS PROVISIONS," and

WHEREAS, said Ordinance No. 634 was recodified and is now contained in Title 17 of the Official Code of the City of Great Falls, adopted upon passage of Ordinance No. 1994 by the Mayor and City Commission on the 6<sup>th</sup> day of April, 1977, to which said Ordinance and any and all ordinances amendatory thereto or supplementary thereto, reference is hereby made; and,

WHEREAS, said Ordinances have placed the property, subsequently subdivided and platted as Jewel Addition to Great Falls, Cascade County, Montana, in a "FIRST INDUSTRIAL", "D" AREA District Classification; and,

WHEREAS, the current owner of Lot 1, Block 1, Jewel Addition, has petitioned the City of Great Falls to rezone subject property to a "PUD" PLANNED UNIT DEVELOPMENT District classification; and.

WHEREAS, notice of rezoning and changing said use and area designation on the above-mentioned property from the existing "FIRST INDUSTRIAL", "D" AREA District Classification to a "PUD" PLANNED UNIT DEVELOPMENT District Classification was published in the Great Falls <u>Tribune</u>, advising that a public hearing on this proposed change in zoning would be held on the 5th day of April, 2005, before final passage of said Ordinance herein; and,

WHEREAS, pursuant to applicable zoning statutes, a hearing was duly held after notice thereof was first duly given according to said zoning statutes, for the purpose of considering changing said zoning on said property to a "PUD" PLANNED UNIT DEVELOPMENT District Classification; and,

WHEREAS, following said public hearing, it was found and recommended that the said change be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning use and area designation on the property hereinabove described be changed from a "FIRST INDUSTRIAL", "D" AREA District Classification to a "PUD" PLANNED UNIT DEVELOPMENT District Classification.

Section 2. All Ordinances and parts of Ordinances in conflict herewith, are hereby repealed.

Section 3. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the Office of the Cascade County Clerk and Recorder the Improvements Agreement and Amended Plat of Lot 1, Block 1, Jewel Addition, related to the Planned Unit Development District, whichever event shall occur later.
