

ORDINANCE NO. 2907

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "GC" GENERAL COMMERCIAL, "D" AREA DISTRICT, FOR BEEBE TRACT 35B, AND A SEGMENT OF 57<sup>TH</sup> STREET NORTH, IN THE NW1/4 OF SECTION 10, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, M. J Wiley Molding, Inc., has petitioned the City of Great Falls to annex Beebe Tract 35B, located in the NW1/4 of Section 10, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, M. J. Wiley Molding, Inc., has petitioned said Beebe Tract 35B, be assigned a City zoning classification of "GC" General Commercial, "D" Area District, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "GC" General Commercial, "D" Area District, to said Beebe Tract 35B, and an approximate 670 foot segment of 57<sup>th</sup> Street North, was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 3rd day of May, 2005, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of Beebe Tract 35B, and an approximate 670 foot segment of 57<sup>th</sup> Street North, be designated as "GC" General Commercial, "D" Area District classification.

Section 2. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the office of the Cascade County Clerk and Recorder the resolution annexing Beebe Tract 35B, and an approximate 670 foot segment of 57<sup>th</sup> Street North, into the corporate limits of the City of Great Falls, Montana, whichever event shall occur later.
