During their terms of appointment as City officials, or at least every two years, whichever is less, all appointed members of City boards, committees, commissions, and councils, shall be required to participate in City sponsored training on governance, open meetings, rights to know, record keeping, public participation and/or other laws and policies impacting local governmental operations.

The City requests all of its members of Boards, Commissions, and Councils to attend this great training opportunity. Training topics are listed on the enclosed flyer and handouts will be provided. Attendees will be asked to sign an attendance sheet verifying their attendance at the training.

This training will be facilitated by Dan Clark, Director of the Montana State University Local Government Center, on Tuesday February 25, 2020, from 5:30 to 8:30 p.m. and again on February 26, 2020 from 5:30 to 8:30 p.m. in the Missouri Room of the Civic Center.
