- Over the years, have noticed some community members are not as willing to be involved
  - Part of the role of the committee is to engage these people
- How are we planning to engage the youth?
  - Alaina very focused on bringing this forth through public engagement effort
  - Working with schools, including higher education
  - Opposite end of spectrum as well elderly community
- Other planning processes, lack of time at the end of the process
  - Need to make sure we incorporate engagement at the end of the process
  - Visualize!
- Public education needs to be part of the process
- Growth policy should evolve; not just a static document
- Growth policy is non-regulatory, but how do you convince the public that the document won't just sit on the shelf?
  - Homebuilders reference the document often
- Need to evaluate the existing plan for success
  - Process will inform changes to zoning code
  - $\circ$  Zoning code rewrite? Maybe, maybe not, depending on what comes out of public process
  - Deep dive into data analysis, to inform policy recommendations in the plan
    - Do we have the infrastructure to support goals of the plan?
- Growth Policy, Downtown Plan very ambitious!
  - $\circ$   $\;$  Important to have realistic goals, achievable vision
  - $\circ$   $\;$  Re-evaluate goals and objectives from 14/15 plan  $\;$
