## MINUTES from the April 11, 2012 meeting

HPAC Chairperson Bob Milford called the meeting to order at 12 noon. Ken Robison moved to approve corrected minutes from the March 2012 meeting (the original version showed Joan Redeen as being both present and absent; she was present). Carol Bronson seconded the motion and commissioners approved the minutes unanimously.

**HPO REPORT:** Among Ellen's activities of the past month was a meeting with Tom Figarelle and Mel Lehman from MSU and Cascade County Commissioner Jane Weber re: the possible repurposing of the Rainbow Powerhouse for MSU's energy program. Ellen also arranged for a tour of the powerhouse for 20 participants. Ellen commented on six telecommunication tower projects and provided city development code information re: toward placement. The Northside walking tour brochure was finalized and sent to the printer.

**PRESERVATION AWARDS:** HPAC members voted unanimously to give Preservation Awards to the following: 1) Public Drug owners Todd LePard and Jeff Jovick for their historic-looking new building on Central Avenue; 2) Rob, Gina and Ashley Forsberg for restoring the First Unitarian Church and parish at 309 4<sup>th</sup> St. N.; 3) Dr. Dale and Pam Schaefer for restoring the house at 606 5<sup>th</sup> Ave. N.; 4) Michael and Charlotte Chamberlain for restoring the house at 623 3<sup>rd</sup> Ave. N.; and 5) Highland Cemetery and the Great Falls Cemetery Association for repairing vandalized gravestones. The free reception will be held from 5:30 p.m. to 7 p.m. on May 24, will feature a soup line.

**VINEGAR JONES CABIN:** Ellen said she would arrange a spring cleaning date for the cabin and also line up volunteers to man the cabin during Wednesday evening Municipal Band concerts this summer.

**DOWNTOWN MASTER PLAN:** City officials plan to include HPAC on the permanent Downtown Master Plan board, Ellen said, rendering unnecessary an earlier plan by HPAC to request a seat at the table.

HPAC's next regular meeting is at noon May 9 in the Rainbow Room of the Civic Center.
