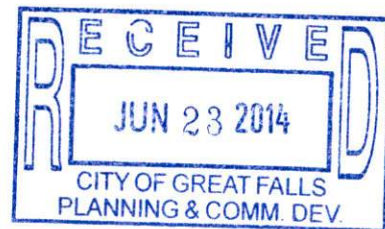
Dear Ms. Amy:
