Lt. LaBard stated that the application(s) of **Rich Hollis, Alice Klundt, Robert Long, Samara Sant, Charles Goodman, Jared Alleman, and Daniel Barnett** were before the Police Commission for their review and discussion. Pursuant to the City of Great Falls Resolution No. 10524, passed and adopted August 1st, 2023, applications must be open to the public even if a sitting member eligible for reappointment wishes to do so as outlined in Section 3 of the resolution.

Section 4 of this resolution allows for and encourages boards and commissions to review all applications and make a recommendation the City Commission regarding the appointment to vacant or open positions.

Commissioner Shanks had completed his second 3-year term and was not eligible for reappointment.
