INVITATION TO BID

Separate sealed bids for construction of the **7**th **Ave NW Street Reconstruction O.F. 1806.1** will be received by the City Clerk at the office of the City Clerk, Room 204, Civic Center, P.O. Box 5021, #2 Park Drive South, Great Falls, Montana 59403, until **9:00 a.m.** local time on **November 22, 2023**, and then publicly opened and read aloud thereafter in the **Rainbow** Conference Room at the Great Falls Civic Center.

The project consists of the reconstruction of 7th Avenue Northwest between the intersections of 12th and 14th Streets Northwest. This includes the removal of the existing asphalt, road base, sidewalks and driveways; sub-grade excavation and compaction; placement of geotextile fabric; placement and compaction of base material; curb and gutter, sidewalk and driveway construction; sodding of disturbed areas; mailbox relocations, and all other activities needed for the roadway reconstruction. The City will pave the asphalt roadway after project completion.

The contract documents consisting of Drawings and Project Manual may be examined or obtained at the office of the City Engineer at the Great Falls Public Works Department, 1025 25th Avenue Northeast, in accordance with the Instructions to Bidders. Required Deposit is \$50.00 per set, which is not refundable. Plans may also be examined at the Great Falls Builders Exchange, though bids must be returned in an original set purchased from the City.

There will be a Pre-Bid conference in the City Engineering Conference Room located at 1025 25th Ave NE at 10:00 a.m., on **November 14, 2023**. Interested CONTRACTORS are encouraged to attend.

Bidder questions will be accepted until **5:00 p.m.** local time on **November 16, 2023** and must be provided in writing via e-mail to Cindy Wojciechowsk. Please call TD&H at 406-761-3010 for Cindy's email address.

CONTRACTOR, and any of the CONTRACTOR'S subcontractors doing work on this project, will be required to obtain registration with the Montana Department of Labor and Industry (DLI). Forms for registration are available from the Department of Labor and Industry, P.O. Box 8011, 1805 Prospect, Helena, Montana 59604-8011. Information on registration can be obtained by calling 1-406-444-7734. CONTRACTOR is not required to have registered with the DLI prior to bidding on this project, but CONTRACTOR and subcontractors must have registered prior to execution of the Construction Agreement. All laborers and mechanics employed by the CONTRACTOR, or subcontractors in performance of the construction work, shall be paid wages at rates as may be required by the laws of the City of Great Falls and the State of Montana. The CONTRACTOR must ensure that employees, and applicants for employment, are not discriminated against because of their race, color, religion, sex or national origin.

Each bid, or proposal, must be accompanied by a Certified Check, Cashier's Check, or Bid Bond payable to City of Great Falls, in an amount not less than ten percent (10%) of the total amount of the bid. Successful BIDDERS, shall furnish an approved Performance Bond and Labor and Materials Payment Bond, each in the amount of one hundred percent (100%) of the contract amount. Insurance, as required, shall be provided by the successful BIDDER(s) and a certificate(s) of that insurance shall be provided. Contractor, and all subcontractors, must be licensed to perform work in the City of Great

Falls prior to contract award.

No bid may be withdrawn after the scheduled time for public opening of bids, which is <u>9:00 a.m.</u>, local time on <u>November 22, 2023.</u>

The right is reserved to reject any or all proposals received, to waive informalities, to postpone the award of the contract for a period not to exceed sixty (60) days, and to accept the lowest responsive and responsible bid, which is in the best interest of the City.
