Yes, any projects selected from the RFP's for construction would be a separate contract.

4) Do you have an anticipated budget for the services?

We are a small community located in a state where money is tight and do not have large resources to draw from.

5) Do you know who was awarded the 2023 Growth Policy RFP or if that has been awarded yet?

The contract has not been awarded at this time.

6) Does the City of Great Falls anticipate having any public engagement outside of the stakeholder group?

There will be no public engagement outside of the stakeholder group and possible Great Falls Development Alliance.

7) How do you see the coordination of this project with the workforce hubs for MAFB taking place?

The workforce hubs will be established by Northrop Grumman for the missile field upgrades and be temporary in nature (3-5 years). They do not have a specific timeline at the present, and will most likely not be in place or have many knowns by the time this project is complete. No coordination needed.

8) Do you anticipate the need for a decommissioning impact analysis associated with the workforce hubs also?

There is no need for a decommissioning impact analysis.

9) Does the evaluation include potential impacts to services such as emergency (fire, police), school district, or parks development?

No, the study will analyze the utility resilience and land use between the City of Great Falls and Malmstrom Air Force Base and develop long-term solutions to benefit both entities.
