- 1.2 <u>Delivery of Bid</u>: Each bid must be signed and submitted in a sealed envelope. Envelope containing bid shall be addressed to the City Clerk, PO Box 5021, Great Falls, MT, 59403 or #2 Park Drive South, Room 204, Great Falls, MT 59401, and plainly marked on the outside with the statement, "2025-26 Water Treatment Plant Chemicals." Signed and sealed bids are due no later than 10:00 AM, Wednesday, APRIL 2, 2025. Bids will be opened in the Civic Center Commission Chambers Room 206 at 10:00 AM, Wednesday, April 2, 2025.
- 1.3 Bid and Performance Guarantee: Bids must be accompanied by a cashier's check, certified check, or bank money order payable to the City of Great Falls and issued by a federally chartered or state-chartered bank insured by the federal deposit insurance corporation; or by a bid bond or bonds payable to the City of Great Falls executed by a Surety Corporation authorized to do business in the State of Montana in the amount of ten percent (10%) of the amount of the bid as a guarantee that the successful bidder will satisfy all requirements of the bid.
