## **Tradeshow and Consumer Shows**

- Ms. Fisher and Ms. Lindseth were invited to the special meeting to discuss consumer show partnerships.
- Russell Country is already partnering with the GFIAP and the CVB to attend the International Sportsmen's Exposition in Denver, CO and the San Francisco Adventure Expo. RC is also partnering with the GFIAP to attend the Puyallup, WA show.
- Several shows were discussed that aligned with the visitors that visit Montana and GF specifically
- Puyallup, WA- O'Laughlin Sportsmen show. January 25-29, 2012
  - o Ms. Thares motioned to fund the Puyallup, WA sportsman show not to exceed \$3000. The TBID will partner with Russell Country and the GFIAP on the Puyallup, WA sportsmen show, January 25-29.
