As expected, this has resulted in confusion for some passengers and some passengers are angry they are no longer receiving service above and beyond what we are required to provide. Because this is new to passengers who are used to receiving services beyond what we are required to provide, we have been, and will continue to make exceptions for passengers until such time as we are sure the passengers

are informed of the rules and familiar with the service requirements. PS Dispatchers are documenting these incidents to the clients record so we can make sure we are providing the passengers with this important information.
